


GENERAL NOTES

- 1. TEMPORARY WORKSPACES AND LIMITS OF DISTURBANCE ARE AS-SHOWN ON THESE DRAWINGS. SPECIFIC NOTES AND DETAILS PERTAINING TO IMPACTS AND CLEARANCES ARE PROVIDED IN THE EROSION AND SEDIMENT CONTROL PLANS.
- CONTRACTOR SHALL MAINTAIN A MINIMUM OF 3 FEET OF COVER IN SOIL OR 2 FEET OF COVER IN ROCK IF NOT SPECIFICALLY STATED ELSEWHERE.
- 3. WETLAND AREAS AND STREAMS AS SHOWN IN THIS PLAN WERE PROVIDED BY GAI CONSULTANTS ENVIRONMENTAL SURVEY.
- 4. THE MERIDIAN IS REFERENCED TO THE "UNIVERSAL TRANSVERSE MERCATOR, ZONE 17, NAD83 DATUM".

- 1. CONTRACTOR SHALL PLACE ONE-CALL NOTICES WITH WV (1-800-245-4848) ONE CALL SYSTEMS AT LEAST 48 HOURS, BUT NOT MORE THAN 10 DAYS, PRIOR TO ANY EXCAVATION ON THIS PROJECT.
- 2. EXISTING FOREIGN UTILITIES AND THEIR RESPECTIVE LOCATIONS AS SHOWN ON THESE PLANS SHALL BE CONSIDERED APPROXIMATE EXCEPT WHERE NOTED. THE CONTRACTOR MUST VERIFY THE EXTENT OF ALL FOREIGN UTILITIES WITHIN THE PROJECT AREA AS WELL AS THEIR SPECIFIC DEPTHS AND LOCATIONS PRIOR TO CONSTRUCTION.
- 3. CONTRACTOR IS RESPONSIBLE FOR COMPLYING WITH ALL PERMITS (FEDERAL, STATE, AND LOCAL).
- 4. ALL FOREIGN UTILITY LINES CROSSED BY THE PROJECT PIPELINE SHALL MAINTAIN A MINIMUM DISTANCE OF 18" OF SEPARATION BETWEEN THE UTILITY AND THE PROJECT
- 5. CONTRACTOR SHALL FOLLOW ALL STANDARDS SET FORTH BY EQUITRANS MIDSTREAM AND FOREIGN UTILITY OWNERS WHILE EXCAVATING NEAR FOREIGN UTILITIES.
